Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 5,40,00,000.00 without VAT**

Minimum Work experience of similar size and nature (ie. at least one Government Building Construction Experience within last 10 years); value of Service for Single Project: NRs. **4,50,00,000.00 without VAT**

5. Electronic bids must be submitted to the office **Marin Rural Municipality, Sindhuli** through PPMO website www.bolpatra.gov.np/egp. On or before **12:00 Noon on 2076/02/10 (24-May, 2019)**. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2076/02/10 (24-May, 2019)** at the Marin Rural Municipality, **Sindhuli**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 15,50,000.00** which shall be valid for 30 days beyond the validity period of the bid.
