Bids will be opened physically at 14:00 hours on the same day of bid submission in the presence of the bidders or their representatives who choose to attend.
6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of as described in details of work and issued by commercial bank, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, it shall be extended to the next working day. In such a case of validity of bid security shall be considered from already specified last date for bid submission.
