## Invitation for Bids

1. The Marin Rural Municipality **has received fund** from **Bagmati provenance** towards the cost of Construction of Football Stadium and intends to apply part of the funds to cover eligible payments under the Contract for MRM/Sindhuli/Works/NCB/9/076/077. Bidding is open to all eligible as per Section V of bidding document.
  2. The Marin Rural Municipality invites electronic bids from eligible bidders for the Construction of Football Stadium under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
- Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 3,93,65,700.00**
  - Minimum Work experience of similar size and nature: **NRs. 2,33,00,000.00**
  - *Other qualification criteria will be as per the Section III of Bid Documents.*
3. The bidder must submit all the require documents as per the Clause 40 of Public Procurement Regulation 2064. If the bidder fail to submit the require document as per the mentioned clause the bid of the respective bidder will be rejected.
  4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
  5. Bidder may download the bidding documents from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit Rs 5,000. the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .



6. Pre-bid meeting shall be held at **Office of Marin Rural Municipality at 1:00 PM 2077/3/2**
7. Electronic bid must be submitted through PPMO's e-GP system ([www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp)) before 12:00 on **2077/03/09**. Bids received after this deadline will be rejected.
8. The electronic bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 PM on 2077/03/09** at the office of **Office of Marin Rural Municipality**. Bids must be valid for a period of **90** after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum **NRs. 8,50,000.00**, which shall be valid for 30 days beyond the validity period of the bid
9. If bidder wishes to submit the Bid security fee in the form of cash, bidder has to deposit cash in Bank Account **Ga-3 Dharauti Account No. 15300303000002** of Rastriya Banijya Bank Kapilakot, Branch - Sindhuli and submit bank deposit voucher along with the electronic bid files.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
