The Marin Rural Municipality has allocated fund for Procurement of School Bus and Dump truck and intends to apply the funds to cover eligible payments under the Contract for MRM/Sindhuli/Goods/NCB/01/2078-079 and MRM/Sindhuli/Goods/NCB/02/2078-079 under National competitive bidding procedures specified in Public Procurement Act and Regulations.

4. Pre-bid meeting shall be held at Marin Rural Municipality, Office of the Rural Municipal Executive, Kapilakot Sindhuli at 14:00 on 2078/06/12.
5. Sealed or electronic bids must be submitted to the office Marin Rural Municipality, Kapilakot, Sindhuli by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 2078/06/19. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2078/06/19 at the office of Marin Rural Municipality, Kapilakot, Sindhuli. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum as shown below which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
