Office of the Rural Municipal Executive, Marin Rural Municipality invites electronic bids from Nepalese eligible bidders for the construction of **Ward No. 1 Ward Office Building Construction** under National Competitive Bidding procedures. The estimated amount for the works is NRs.1,66,80,925.10.

Bidders, submitting their bid electronically, should deposit the cost NRs. 3,000.00 of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Office of the Rural Municipal Executive, Marin Rural Municipality, Kapilakot, Sindhuli** at 13:00 on **2081/06/06 (2024/09/22)**.
5. Electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egp on before 12:00 PM on **2081/06/22(2024/10/08)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 on 2081/06/22(2024/10/08)** at **Office of the Rural Municipal Executive, Marin Rural Municipality, Kapilakot, Sindhuli**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 4,20,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2081/10/22).
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
